**CALIFORNIA COMMUNITY CHOICE ASSOCIATION’S SUBMISSION OF
COMMENTS ON IOU POST-EVENT REPORTS**

As instructed in the December 23, 2019 *Assigned Commissioner’s Amended Phase 2 Scoping Memo And Ruling* (“Scoping Ruling”), the California Community Choice Association (“CalCCA”) hereby submits into the record for this proceeding, Rulemaking (“R.”) 18-12-005, the below-listed comments on investor owned utilities’ Public Safety Power Shutoff (“PSPS”) post-event reports. In this proceeding CalCCA represents the interests of its members, California’s CCA programs. As such, CalCCA is submitting into the record both comments submitted by CalCCA itself and by four of CalCCA’s member programs (a set of joint comments submitted by Sonoma Clean Power Authority, Marin Clean Energy, and Pioneer Community Energy, and a set of comments submitted by Lancaster Choice Energy).
